AFIH (Association Fellowship in Industrial Health or DIH (Diploma in Industrial Health) or equivalent qualification from Central Labour Institute (CLI) or National Institute of Occupational Health (NIOH) or any recognized Government Institute. The additional experienced may be relaxed in case of deserving candidates.

Terms

1. The engagement of above doctors shall be purely on contract basis at ONGC's Field installations/Rigs/Drill-Site Accommodations at Jorhat/Golaghat (or any other district of Assam where ONGC Basin is operating), at the discretion of ONGC, for the period stated above for which an agreement is to be executed on Non-judicial Stamp Paper of ₹ 20/- and can be terminated by giving one month's notice from either side.
2. No claim for regularization in ONGC shall be entertained by virtue of this contract agreement.

The Medical Officer (s) shall be required to perform duty at various ONGC Dispensaries situated at Jorhat/Golaghat like City Dispensary, Cinnamara Dispensary & Dispensary at AB Type Colony, Jorhat & Drill-Site Accommodations of ONGC on 14 days on/off duty pattern; the deployment will be at the discretion of ONGC.
