

Require Field Operator for Rajahmundry Asset, Rajahmundry

ONGC, Southern Sector requires Field Operators for engagement in different operations at Onshore on a fixed tenure of 04 (four) years to meet the requirements of the work plan for Hydrocarbon Blocks awarded to ONGC at Rajahmundry Asset, Rajahmundry through NELP bidding. The job demands outdoor field work in shifts requiring considerable physical efforts and technical skills, and frequent relocation as demanded by the semi-mobile nature of the operations to any Onshore/Offshore locations within the Country. The details of post are given below:

The details of the eligibility criteria viz., experience, age limit, physical standards measurements test, physical efficiency (fitness) tests, and Application Format etc. are given below which may be read carefully before applying. The requirement has also been notified to the Employment Exchanges at Vijayawada , Eluru, Kakinada, Rajahmundry & ITDA, K.R.Puram . Candidates who meet the following criteria and are willing to be engaged on a fixed tenure of four (4) years may apply

A. QUALIFYING CRITERIA :-

1. Age limit:

30 years for General candidates, 33 years for OBC & 35 years for SC/ST candidates as on 19.10.2007.

2. Educational/Professional Qualifications:

a. Essential:

1.High School (Class X) pass & 2. ITI in Fitting / Diesel / Turner / Machining/ Welding /Diesel Mechanic/ Mechanic (Diesel vehicle)/ Mechanic (Motor vehicle) with 60% marks in ITI for Gen & OBC & 50% marks for SC/ST candidates.

b.Desirable:

1.High School (Class X) pass & 2. ITI in Fitting / Diesel / Turner / Machining/ Welding /Diesel Mechanic/ Mechanic (Diesel vehicle)/ Mechanic (Motor vehicle) with 65% marks in ITI for Gen & OBC & 55% marks for SC/ST candidates and valid Driving License for Heavy Vehicle /Heavy Goods Vehicles as on date of application will be preferred.

B. PHYSICAL & FITNESS REQUIREMENTS:

1. Physical standard :

a) For Gen & OBC candidates:

(i) **Height** -167 Cms. (ii) **Weight** - 58 Kg (iii) **Chest** at expiration 81 Cm. After inspiration 86 Cm.(iv) **Vision** 6 x 6 without glasses without any history of night/ colour blindness etc.

b) For candidates from Hill Areas, SC/ST and Tribal Areas:

(i) **Height** 162 Cm (ii) **Weight** 50 Kg. (iii) **Chest** 79 Cm. at expiration, 84 Cm after inspiration. (iv) **Vision** 6 x 6 without glasses without any history of night/ colour blindness etc.

2) Physical Fitness requirements:-

With one arm transport 20 Kg. object to 100 feet distance or 30 steps upstairs.

With two arms transport 40 Kg. over 25 feet distance

Climb a vertical ladder 100 feet.

Swing 5 Kg. sledge hammer -15 times (5 times overhand , 5 times underhand, 5 times side arm motions).

C. Remuneration:

A consolidated salary of Rs. 15,500/- inclusive of all allowances. An annual increment of 4% is admissible on the tenure pay, subject to satisfactory performance. For the limited purpose of determining various entitlements the tenure pay would be deemed to be Rs.5000/- per month. The annual increment of 4% would be on the tenure pay. Additionally, PF and Bonus shall also be paid as per statutory rules.

D. Other conditions.

a) These requirements arise in order to meet the time bound work program for hydrocarbon blocks, awarded under NELP bidding. As the work program is time bound and may change depending upon assessments after initial work, these requirements and engagements are limited to a fixed tenure of four (4) years only. The Tenure appointment will automatically cease on completion of the stipulated period of Tenure appointment. Further, the engagement may be terminated at any time, during the period of tenure appointment by either side by giving one month's notice or the fixed wages in lieu thereof.

b) The work is demanding and requires very high level of physical fitness. The deployment may be on round the clock shift pattern of work. The standards prescribed for test of physical fitness is illustrative of the nature of the work.

c) Selected candidates may be assigned to work in any onshore or offshore location in India, during the tenure.

d) Selected candidate shall be required to sign an undertaking to the effect that their engagement on tenure basis will not entitle them for any regular employment and that they shall not prefer any claim for regularization of services in ONGC.

e) Reservation is applicable as per Government of India directives.

E. Selection Procedure:

a) After initial screening, the candidates will be required to undergo written tests, physical fitness tests and interview, in any sequence as decided by ONGC.

b) No TA/DA is admissible for attending written test, physical fitness tests or interview.

c) Candidates meeting the above qualifying criteria and registered with any of the Employment Exchange at Vijayawada , Eluru, ITDA, K.R.Puram, WG Dist, Kakinada, & ITDA-Ramachandrapuram, EG Dist. may only apply by submitting an application typed on A-4 size paper, affixing a latest attested passport size photograph on upper right hand corner of the application as per the Annexure-I on or before 30.11.2007.

F) IMPORTANT POINTS TO NOTE:

1. The selection will be subject to possession of Metric (Std. X pass) and Technical Qualification as mentioned above. ITI should be recognized by State Council of Technical and Vocational Training (SCTVT) / National Council of Technical and Vocational Training (NCTVT)
2. Following documents in original are required to be produced at the time of Test/ Interview (without which candidates will not be allowed to appear in the Test/ Interview)
 - i) Proof of Date of Birth, Pass Certificate & marks list of Academic and Technical Qualifications.
 - ii) SC/ST/OBC (with Non-creamy layer) Certificate, if applicable, in the prescribed format duly signed by Competent Authority of State Govt.
 - iii) Employment Exchange Registration Card/Certificate.
3. In addition to photo copies of all the documents duly attested as mentioned above, one passport size recent photograph (attested) to be brought at the time of physical fitness test / personal interview.
4. Short listed candidates will undergo physical standard measurement Test, Physical fitness requirement Test, written Test and personal Interview in any sequence as decided by ONGC. Candidates qualifying all the above tests will be selected in order of merit.
5. Candidates will be put on test for the physical Parameters – Height, Weight, Chest, Vision and are required to undergo the Physical Fitness Test activities as mentioned at para B) above , as a part of the selection process for recruitment of Field Operators on Tenure Basis, on their own free will and consent, and will not hold ONGC responsible for any injury or mishap / accident. Further , candidates will have to follow the safety guidelines as explained to them before the test.
6. A common written test paper consisting of 120 objective type questions will be held in English. (100 technical questions from the trades of Fitting / Diesel / Turner / Machining/ Welding /Diesel Mechanic/ Mechanic (Diesel vehicle)/ Mechanic (Motor vehicle) + 20 General Knowledge).
7. Selection is purely on merit basis. Candidates should not bring any pressure/ influence through any channel of whatsoever. Bringing influence at any stage of selection process will disqualify the candidature.
